

WORK CONTRACT

In Ntrafi, Rafina, today, 20/09/2021

Between the civil non-profit organization CRE.THI.DEV. (ΔΗ.ΣΚΕ.ΑΝ. in Greek) based in Ntrafi, Rafina, with Tax Registration Number 997608917, Pallini tax office, henceforth the "COMPANY"

and

Nikitas Nikitakos, located in 164, Nikitara Street, Piraeus, 18546, Greece, with Tax Registration Number 022798536, tax office E' Piraeus, henceforth the "PARTNER".

The following were agreed upon:

The COMPANY subcontracts to the PARTNER the External Quality Audit of the approved project "DeCAIR: Developing Curricula for Artificial Intelligence and Robotics", ref.no.: 618535-EPP-1-2020-1-JO-EPPKA2-CBHE-JP, within the framework of the Erasmus Plus Programme, Capacity Building for Higher Education.

The PARTNER, as the project's External Quality Evaluator, will be responsible for the implementation of the External Quality Assessment of the project in close collaboration with all members of the Quality Committee and the project leader of the DeCAIR project, according to the framework defined in the approved project. Specifically, his tasks will include:

- Use of independent tools (e.g. questionnaires, personal interviews) to assess the implementation of the project and its deliverables.
- Contribution to the project that derives from the Quality Assurance and Evaluation Plan and its possible future amendments or specific requests made by the EACEA (Education, Audiovisual and Cultural Agency).
- Visits to Jordan and Lebanon for the purpose of the preparation of the intermediate report might be required, if the circumstances allow it.
- Preparation of two Quality Assessment Reports (Due date: 14 September 2022 and 14 December 2023) as described in the Quality Assurance and Evaluation Plan of the project.
- Input for the development of the final evaluation report of the project at end of the third year.

The COMPANY, as project member and Quality Assurance Work Package leader, is obliged to provide the PARTNER all necessary information regarding the project, its results and its outcomes, as soon as they are available, to facilitate their evaluation by the PARTNER.

The PARTNER is obliged to act according to the directions of the COMPANY'S delegate and deliver all work assigned to him within the time frame and according to the requirements defined by the project.

The result of the work carried out in the framework of the aforementioned project belongs to the COMPANY, as member of the project partnership.

The contract duration is from 20/09/2021 to 14/01/2024 and the PARTNER'S payment is set at 10.000€ (ten thousand euro).

The payment will be made in 3 installments after each Quality Assessment Report and after the final evaluation report has been delivered. For each payment the COMPANY will issue a proof of payment.

The contract was issued in three copies and each received a signed and sealed copy (and one for the tax office).
