Changes that have occurred in this result since the original proposal:

- (*) The Quality Assurance & Evaluation Plan as a document, needed more time to be developed, discussed and finalized by the consortium. Since it is a living document that will be used through the project's lifetime, it is best to be as complete as possible, avoiding thus the need for later amendments to its main content. However, all quality management actions have been implemented from the beginning of the project.
- (**) Due to the different added/modified courses in existing master programs in universities of partner countries, more time for that task was needed.
- (***) Due to some internal procedure delays regarding the development of the Quality Assurance & Evaluation Plan (QAEP), the deadline for the submission of the first Quality Report according to the QAEP has been missed. The 1st Quality Report covers the 1st year of the project, i.e. from January 15, 2021 until January 14, 2022 and is a combination of the 1st and 2nd report. Also that task for the better monitoring of the progress project was decided to end at the last month of the project in order the development of the final semester Quality Report to be submitted.
- (****) Due to conflicting calendars, it was decided the external evaluator to visit JO and LB later in the lifetime of the project and not before submitting his 1st report.
